hereby apply for registration as a member and player with the Namibia Ice and Inline Hockey Association (NIIHA), and hereby declare and agree as follows:

I hereby unconditionally and irrevocably submit to the authority, the Constitution and all the rules, regulations, requirements and directives of the Namibian Ice and Inline Hockey Association (NIIHA) in respect of my participation in any recreational or competitive ice hockey and inline hockey in Namibia, and agree to be bound thereby. More specifically, I agree that it is my legal duty to know and understand the Constitution, rules, regulations, requirements and directives of NIIHA.

I am aware of, and unconditionally accept that Ice hockey and Inline hockey is a potentially dangerous contact sport and poses the risk of serious personal injury, as well as damage to or loss of property for players, participants and spectators. I voluntarily assume and accept all risk of participation in such sport and agree that any such participation in any recreational or competitive ice hockey and inline hockey is and will be, wherever it takes place and organized by whomever, shall always be entirely at my own risk. My participation in and presence at any other activities, which includes, but is not limited to any recreational games, team trials training camps or official or national tournaments and recreational or social events of NIIHA or its member clubs which may be offered or conducted by NIIHA or its affiliated clubs or other organizers, is likewise entirely voluntary and at my sole and own risk.
 3. I indemnify and hold harmless NIIHA, its' affiliated member clubs or any other organizer of any other event in respect of any acts or omissions which may cause me personal injury, or patrimonial losses or damage, including any direct damages or consequential damages or pure economic loss and I hereby waive all such claims that I may have in law against NIIHA, or its member clubs, or any other organizer of any event related to the sport to the fullest extent allowed by Namibian law. I likewise hereby indemnify and hold NIIHA or its member clubs or any other organizer of any event related to the sport harmless against all such claims either by myself and/or any third party claiming or entitled to claim on my behalf to the fullest extent allowed by Namibian law.
